# Witness Collapses at Trial



### Woman Asserts Former Husband Once Attempted to Kill Her

Mrs. Aeron Burnet, 39, collapsed on the witness stand in Justice Court at 11:30 a.m. Tuesday after testifying that her former husband, shot to death Feb. 22, had once tried to kill her and had threatened the life of her present husband, Owen Arthur Burnet, charged with the slaying.

Examining trial for Burnet, exsailor, was postponed until 9 a.m. Friday after Mrs. Burnet had been revived by Dr. J. M. Pickard, assistant county health officer, and carried from the courtroom.

She grabbed at her heart and slumped in the chair during a bitter cross-examination by Special Prosecutor Frank Wilson. Justice of the Peace W. L. Sterrett immediately recessed the hearing and called Dr. Pickard to the scene.

Bruton Shot in Office.

Burnet, charged with the pistol slaying of Laster B. Bruton, his wife's wartime husband, was present at the hearing. He is free on \$5,000 bond.

Bruton was shot to death in his

office in the Texas Bank Building. Burnet surrendered an hour afterward at the Sheriff's office.

Mrs. Burnet, wearing dark glasses and a turn-down hat, testified that she first married Burnet in 1936, after a childhood romance in Ohio.

Mexican Divorce Granted.

She obtained a Mexican divorce, arranged by Bruton, in a lawyer's office in Matamoros in 1942, and married Bruton the same day, Mrs. Burnet said. Burnet, who had enlisted in the Navy, agreed, she said. Bruton had called her for dates as early as 1938, and she played golf with him once, she said.

After the Mexican marriage they were happy for about thirty

days, she said.

Later, on one occasion she surprised Bruton with a 16-year-old girl in his office, and on another occasion Bruton became enraged at her during an argument and shot at her with a .22-caliber pistol, but missed, she said. That time she

## Jury to Probe Burnet Case

The Owen A. Burnet murder case will be turned over to the Dallas County Grand Jury for investigation, Justice of the Peace W. L. Sterrett said Monday.

Special Prosecutor Frank Wilson has waived further cross-examination of Mrs. Aeron Burnet, 39, wife of the defendant, Sterrett said. Mrs. Burnet is still confined to

her residence as the result of her collapse during cross-examination at an examining trial before Justice Sterrett March 6.

Burnet, 39, is charged with the pistol slaying of Laster B. Bruton, Dallas business executive, shot to death in a downtown office building on Feb. 22.

Burnet, ex-sailor, free on \$5,000 bond, was married to Mrs. Burnet before the war. She divorced him in 1942 to marry Bruten.
